 - a) MOTION: APPROVAL OF MINUTES OF 2022 ANNUAL GENERAL MEETING
 MOVED Brad Quiring SECONDED Terry Janke that the MINUTES for the 2022 Manitoba Baptist Association Annual Business Meeting be approved as adjusted. CARRIED

 - a) MOVED Barry Thiessen, SCONDED Doug Legall that the agenda of the 2023 Annual Business Meeting be accepted as presented. CARRIED
- 6. Presentation of the 2024 Budget Al Donald
 - a) December 31, 2022 Financial Statments
 MOTION AI Donald SECONDED Doug Legall that the 2022 Financial Statement be accepted as presented. CARRIED
 - b) 2024 Budget
 - i. Budget Notes
 - ii. 2024 Budget Proposal
 - 1. A number of churches are facing financial difficulties, therefore the contributions from churches to the MBA has fallen, thus there is financial strain on the MBA.
 - 2. One of the biggest budget challenges is supporting the Regional Minister because of the exchange rate and inflation.
 - c) MOTION AI Donald SECONDED Marno Klein by Stephen Moir that the 2024 MBA Budget be accepted as presented. CARRIED
 - i. QUESTION: Is it prudent to reduce the RM's portion from \$75,000.00 to \$67,000.00? Can it be returned to \$67.000.00.
 - 1. ANSWER: Cost of living has risen sharply. This increase reflects financial reality. Both the North Central Association and Manitoba sides are behind and need to use savings to

meet budget requirements. There is nothing in the budget that can be realistically reduced.

- ii. QUESTION: How much money is in the bank?
 - 1. ANSWER: reviewed the bank accounts.
- iii. QUESTION: Southdale Church and Central money, how long is it restricted?
 - 1. ANSWER: Indefinitely, it is assigned to outreach, church planting and pastoral training.
- iv. QUESTION: What is the "mortgage receivable"?
 - 1. It is from the Central Baptist Church sale.
- v. COMMENT: There was an indication from NAB that 2-3% be given to MBA.
- vi. QUESTION: Is it time to free up restricted money?
 - 1. ANSWER: The problem with restricted funds: it is difficult to switch restricted funds to non-restricted. Agreements were made.
- vii. QUESTION: in 2022 Financial Statements there is a large amount of money in unrestricted accounts?
 - 1. It was a labelling error the from accountants.
- viii. QUESTION: We have restricted funds that can be released.
- ix. QUESTION: Can we pay 40% of RM in Canadian funds and up vacation time?
 - 1. Agreement states we must cover 40% of real costs.
- x. QUESTION: Benefit to the salary fund being in a US Dollar account?
 - 1. ANSWER: You have to first buy US dollars before putting into the US account. Most of the time it is difficult to find a good exchange.
- xi. Can we renegotiate agreement?
 - 1. ANSWER: We would have to break current agreement and renegotiate.
- xii. QUESTION: Why are there no funds allocated to MBYA?
 - 1. ANSWER: Up until July 23 there has been no activity from MBYA. A special event was planned and paid out. \$3000.00 has been allocated for 2024 events.
- xiii. COMMENTS: MBYA in past had a combination of budget and selffunding. We know there are options to unrestrict funds.
- xiv. QUESTION: What is the relationship between the RM and the MBA churches? Should we consider expanding or changing the boundaries of the region?

- 1. ANSWER: The regional model we have now is a result of a change in the NAB to move the RM's to the Regional Leadership Teams. Changing regions is something to be done by the Regions.
- xv. QUESTION: How is the AGM paid for?
 - 1. ANSWER: Self-funding.
- xvi. QUESTION: Can the cost of the Pastors' Retreat be reduced or split?
 - 1. ANSWER: It can be split.
- xvii. QUESTION: Special fundraisers? Are there limitations?
 - 1. ANSWER: No limitations beyond planning and executing. The executive doesn't have the manpower, but others stepping up to do this would be good.
- xviii. COMMENT: Adding Saskatchewan to the region is worth pursuing as a growth.
